

CEMATRIX Announces \$3.9 Million in New Contracts; Backlog Continues to Grow

Calgary, Alberta – June 16, 2022 – CEMATRIX Corporation (TSXV: CVX) (OTCQB: CTXXF) ("**CEMATRIX**" or the "**Company**") a North American leading manufacturer and supplier of technologically advanced cellular concrete products announced that its wholly owned operating subsidiaries, which include CEMATRIX (Canada) Inc. ("CCI"), MixOnSite USA Inc. ("MOS") and Pacific International Grout Company ("PIGCO") have executed \$3.9 million in new contracts.

Factoring in these \$3.9M in new contracts, the converted contracts, the new contracts in process and sales completed to date, the Corporation's backlog now totals \$87.9 million. \$22.4 million of the Corporation's backlog is Contracted and \$65.5 million is Contracts in Process.

"Of the \$3.9M in new contracts, \$2.4 million is attributed to an overpass backfill project which is scheduled to commence in August of this year," stated Jeff Kendrick, CEMATRIX President and CEO. "The balance of the new contracts together with the new contracts in process represent new infrastructure projects of various sizes all under \$1 million and are from all regions in the United States and Canada. Each of these projects are scheduled to be completed in the current year. Bid activity for infrastructure and tunnel projects throughout North America continues to remain strong and even though supply chain issues have created some short-term delays in some of our projects, our suppliers expect to meet our requirements for the year."

The Corporation's Backlog is defined as Contracted plus Contracts in Process net of sales completed to date. Contracts in Process are defined as projects where the related contract is in office for review or signature; or signed and returned to the client for their signature; or is in the post award project submission process; or is awarded by letter of intent; or is awarded by some other form of written communication.
