CEMATRIX Corporation Announces New Contracts

Contracted Revenue For 2018 Completion Now Exceeds \$20.2 Million

Calgary, Alberta – July 25, 2018: CEMATRIX Corporation (TSXV: CVX) (the "**Corporation**" or "**CEMATRIX**") announces that its wholly owned operating subsidiaries, CEMATRIX (Canada) Inc. and MixOnSite USA Inc. have secured \$1.4 million in new infrastructure contracts. These new contracts increase this year's contracted sales to \$23.5 million, \$20.2 million of which are scheduled for completion in 2018.

Total contracts and verbally awarded projects for CEMATRIX Group, now exceeds \$31.1 million for 2018, of which \$6-\$7 million will likely carry over into 2019/20.

"These new North American infrastructure projects continue to confirm a record year for CEMATRIX for 2018." stated Jeff Kendrick, CEMATRIX President and CEO. The record year is due to accelerated growth of Canadian sales and sales from its newly acquired US subsidiary, MixOnSite.

The Corporation, through its wholly owned subsidiaries, is a rapidly growing company that manufactures and supplies technologically advanced cellular concrete products developed from proprietary formulations.
